iv) Outstanding dues of the Association, if any (details of which may be had from Accounts Sections of the Association).

3. The Up-country members are requested to kindly make necessary payment by **Demand Draft** drawn in favour of "**the Karachi Cotton Association**" on any scheduled Bank in Karachi by due date.

4. In case, members do not arrange payments and furnish necessary documents as mentioned above by **31-03-2018**, their membership of the Association for the year 2018-2019 may not be renewed and they may cease to be the members of the Association **as no provision for further extension under the Trade Organizations Act/Rules 2013 for renewal of membership of the Association has been provided**.
