### **COTTON SITUATION**

### 06. **To discuss the cotton situation.**

In reply to a query, Mr. Asif Inam stated that till the issue of energy was not resolved by the Government, the local textiles industry could not be able to take full benefits / advantages of the Textile Package announced by the Government.

Reply to other query, Mr. Asif Inam stated that the growers in India were not well organized, therefore, there was no effect of growers upon the trend of increase in price of cotton in India. He also stated that cotton crop in India would be around 30.00 - 30.20 million bales.

Mr. Nasir Anwer Barkhurdaria stated that except the Denim Sector, the position of other sectors i.e. Knitting and Towels sectors were not promising.

As regard cotton crop in Pakistan, the Committee observed that according to the PCGA's Report dated 18-02-2017, total arrivals of cotton in the ginneries were recorded as 10.685 million bales as on 15-02-2017 as compared to 9.687 million bales in the corresponding period in last year.
