# 2. TO ADOPT THE DIRECTORS' REPORT (REPORT OF THE EXECUTIVE COMMITTEE) FOR THE YEAR ENDED 30-06-2022.

Mr. Rizwan Iqbal Umer proposed and Mr. Nadeem Maqbool seconded that the Directors' Report (Report of the Executive Committee) for the year ended 30-06-2022 may be adopted.

The General Body unanimously adopted the Directors' Report (Report of the Executive Committee) for the year ended 30-06-2022.

## 3. TO PASS THE AUDITED FINANCIAL STATEMENTS OF THE ASSOCIATION FOR THE YEAR ENDED 30-06-2022.

Mr. Abdul Jabbar proposed and Mr. Muhammad Asif seconded that the Audited Financial Statements of the Association for the year ended 30-06-2022 may be adopted.

After discussion, the General Body unanimously adopted the Audited Financial Statements of the Association for the year ended 30-06-2022.

## 4. TO APPOINT AUDITORS FOR THE YEAR 2022-23 AND TO FIX THEIR REMUNERATION.

Chairman informed the General Body that M/s. Tariq Abdul Ghani Maqbool & Co., Chartered Accountants vide their letter dated 27-08-2022 had informed that they were willing to continue as Auditors of the Karachi Cotton Association for the financial year ending 30-06-2023 at annual remuneration of Rs. 183,000/- excluding out-of-pocket expenses and sales tax on service.

He also informed that M/s. Ghouri & Co, Chartered Accountants vide their letter dated 29-08-2022 had also expressed their willingness to act as Auditors of the KCA for the financial year ending 30-06-2023 at annual remuneration of Rs. 118,800 inclusive of SST.

Chairman further informed the General Body that M/s. Tariq Abdul Ghani Maqbool & Co., Chartered Accountants, were appointed as Auditors of the Association by the General Body in its meeting held on 23-09-2021 for the year 2021-22 ending 30-06-2022, at an annual remuneration of Rs. 165,000/- plus SST.

The General Body unanimously resolved that M/s. Tariq Abdul Ghani Maqbool & Co., the retiring Auditors, who offered their services as Auditors of the KCA for the year 2022-23 ending 30-06-2023, be appointed as Auditors of the Association for the year 2022-23 ending 30-06-2023 at an annual remuneration of Rs. 183,000/- excluding out-of-pocket expenses and sales tax on service.
